Confirmation & Deposit Fee

An event booking is confirmed only upon deposit being paid. Your deposit of \$500 will be deducted from your final account on the day of the event. Ample reserves the right to cancel the tentative booking should the required deposit not be received within the required period.

Security & Final Payment

Full payment of the outstanding bill (less deposit taken) must be received at the conclusion of your event.

Notice of Cancellation / Postponement

In the event of a cancellation or postponement, 21 days prior notice to the function date is required.

Ample requires notice of any cancellation or postponement.

Final Attendance

Final guest numbers are required 7 days prior to your function. This will be the minimum number of guests you will be charged for. Any further increases will be welcomed subject to availability. All billing will be based on this figure whether or not full attendance is received.

Evening Functions

Ample Café & Bar is fully licensed until 11pm. Should you wish to extend the duration of your function, please advise us at the time of your booking so that we can take the necessary steps to apply for a liquor license beyond 11pm. A surcharge may apply.

Menus & Beverages

Menus and beverages are subject to change. Finalization of the menu must be received 7 days prior to your event, along with any dietary requirements.

Entertainment / Special Effects

Ample can provide you with additional entertainment and extras such as DJ, candy buffet, balloons and other decorations upon request. Please speak to us about your requirements.

The client must inform Ample of any planned entertainment or performances at the event at least 5 business days prior to event

commencement. Ample must be notified in writing of any smoke, pyrotechnic or special effect equipment to be used during the event. Should the fire brigade be called in response to alarm set off by unauthorized equipment, the Client will be liable for all relevant charges incurred by the operation.

Alcohol Provision, Consumption & Behaviour

Ample Café & Bar supports the Responsible Service of Alcohol. Clients will be held responsible for ensuring that their guests behave in a responsible manner and that guests under the age of 18 years do not consume alcohol.

- Ample reserves the right to refuse the supply of alcohol to patrons who appear to be intoxicated.

Responsibility
